#### **Dear family of First Presbyterian Church:**

I am still filled with joy from our Sunday worship experiences on May 7 as I write this letter on Monday afternoon! Thank you to all of you who attended and participated in our confirmation and installation worship services on Sunday! In our morning worship service, we confirmed four new members of our church and heard them share their statements of faith. It was an inspiring moment in the life our church and in my own life. In the afternoon, we celebrated my installation as your pastor and the shared ministry that we are called to participate in! I know it is difficult to make it to multiple worship services in one day, so over the next few weeks in the Home Page, I will be sharing different parts of these services that give me so much hope for the future of our church. Below is the opening of the sermon preached by my friend Rev. Dr. Christine Chakoian at the installation service based on Philippians 2:1-18 and John 21:15-19. Please prayerfully reflect on these words and what they mean for each of you as well as our church as we begin our ministry together.

I suspect that, for Greg and Jessica, and for the search committee and the congregation, there is both a huge sigh of relief and a deep sense of excitement: the waiting is over, and the work of the search is done!

But of course, in many ways, the most important work is just beginning. For it is precisely now — as you start your ministry together — that you are shaping the values, patterns, and relationship that will define your identity together. It is precisely now that it's key for you to decide: what is it you aspire to in this new season? Who is it you aspire to be, as individual Christians, and as a congregation? What does success look like?

It's a key question facing every church these days. And I have to acknowledge that there are key components that can't be ignored: fiscal responsibility; inspiring worship; effective Christian education; and more. Institutional well-being is a part of the faithful stewardship of what we inherit from those who came before.

But for too many of us, we tend to stop there. We measure our church's success in terms of the number of young families we're attracting. We measure our church's well-being in terms of the number of "people in the pews." We measure our church's health in terms of income and loss. But if that's all we're measuring - if institutional survival is our highest aspiration – then haven't we missed the point of faith?

Which leads me to our Scriptures for today. Let's start with Paul's letter to his beloved church in Philippi. Like you, they're discerning their future, and they're wondering how they'll navigate the challenges and changes ahead. Paul has a clear word for them. This is what Paul desires for his most beloved congregation: not that they worry about survival. Not that they concentrate on growing. Not that they focus on money. No, what Paul wants more for them than anything else is this: he wants them to grow to be Christ-like. Isn't that still our highest aspiration?

How do we aspire to be like Christ? What does it look like to follow Jesus? I love Jesus' words to Simon Peter: "Do you love me? Feed my sheep. Do you love me? Tend my lambs." This instruction to love others, to tend to others, is exactly what Paul says to his beloved Philippians:

"If there is any encouragement in Christ, any consolation from love, any compassion and sympathy, make my joy complete: be of the same mind, having the same love, being in full accord and of one mind. Do nothing from selfish ambition or conceit, but in humility regard others as better than yourselves. Let each of you look not to your own interests, but to the interests of others."

#### **DISCLOSURE**

In connection with your application for employment with First Presbyterian Church including any independent contract for services and volunteer work (hereinafter "Employment) or when deciding whether to modify or continue your ongoing Employment, First Presbyterian Church may obtain a "consumer report" and/or an "investigative consumer report" on you from Praesidium, Inc., a consumer reporting agency, or from any third party, in strict compliance with both state and federal law. A consumer report is a communication of information by a consumer reporting agency bearing on your credit worthiness, credit standing, credit capacity, character, general reputation, personal characteristics, or mode of living which is used or expected to be used for purposes of serving as a factor in establishing your current and/or continuing eligibility for employment purposes. An investigative consumer report is a report obtained through personal interviews with individuals who may have knowledge of your character, general reputation, personal characteristics, or mode of living. The consumer reports or investigative consumer reports may contain information regarding your credit history (if applicable to position), criminal records, driving history records, education records, previous employment history, social security traces, military records, professional licensure records, drug testing, government records, and other types of background information. This 'above and beyond' effort was opted by the Mission Committee in consideration of those who eat sack lunches regularly.

The cost to fill the total need was \$5,318.82.

The Open Table Fund has a 2017 beginning balance of \$3,052.03, which is a great start!
