# **POINSETTIAS**

Poinsettias may be purchased in honor or in memory of a loved one. The cost is \$15 each. Money raised over the cost will be donated to Salvation Army Utility Assistance Program, which provided \$24, 627.75 towards utilities assistance in the last 12 months. Funds helped 404 people with necessary electricity, water and gas, of which 382 were in families - 70 were children under the age of 5 and 85 were children aged 6-10. 7 of the 404 people assisted were over the age of 62. As with all of The Salvation Army's programs, utilities assistance is an emergency service. To qualify, individuals and families must have received a disconnect notice and meet qualifications of need.

# Minutes - First Presbyterian Church Foundation Meeting 11-21-16

Attending: Roger Doerr, John Northrup, Dave Dirks, Nancy Langford, Justin Wenburg, Kay Georgiana & George Howard Guest: Jane Bauer

- 1) Opening prayer by Doerr
- 2) We reviewed the 8-15-16 meeting's minutes. It was moved by Langford, with a 2<sup>nd</sup> by Northrup to approve the minutes. Motion carried.
- 3) Treasurer's Report
  Wenburg said the balance of \$612.42 had not changed. The Treasurer's report was accepted.
  Wenburg will contact Oakeson to transfer \$1,000 to the Foundation checking account to pay
  Contryman's for their work on the 990 IRS form and filing. The 6 Foundation funds will share in
  the expense on a pro rata basis.

# 4) Jane Bauer/Completing/Filing 990 IRS form

Jane is no longer working for Contryman's and no longer has access to software needed to file IRS Form 990 for our Foundation. As a stop-gap measure, Jane suggested the Foundation could contract with Contryman's for a fee of \$1,000, which was approved at a prior meeting. Jane gave Howard a copy of the 990 Form for our records. Jane wanted the Foundation to note that the form was completed differently for 2015. The form showed liabilities (previously always zero) for the Foundation of \$1,976,667 as of 12-31-15. Jane and Julie Moller's thinking was that the Foundation was simply holding/managing those funds for the church, but it was really the church's money. It appears the Langenburg fund was excluded from the liability calculation.

Howard asked what the offset was for the liability and Jane stated none (no accounts receivable) would be made on the church's balance sheet. Howard noted the funds were actually in the Foundation's name, so it was suggested that Howard and Bauer research this asset/liability treatment with other local Foundations to consider making different accounting entries. It was decided to file the 990 form as it stands and if a different account treatment was suggested, then an amended form could be made and filed in the future. (Subsequent to the meeting, Howard discussed the accounting entries with Oakeson and Doug Oakeson reported that he hadn't seen this anywhere before, so he suggested we contact other Foundations or accounting practices for their ideas.)

Jane had all of the members present sign their annual conflict of interest form. This will be an annual requirement and then we can deliver them to her.

- 6) Investment Update -Howard:

# Quarterly Investment Update

Howard discussed the 9-30-16 Excel spreadsheet which calculates the present percentage of the large fund, which each of the 6 sub-funds own. Only about \$150,000 of the authorized \$350,000 movement from short term investments to higher yielding stock or bond funds had been accomplished in the last 45 months, for the Session's funds, due to the high prices of bonds and stocks at this time. All of the 6 sub-funds had gains of about 3% during the 3rd Quarter, 2016. \$500 of the \$3,305 in Essex Scholarship funds have been awarded. Howard noted Oakeson hadn't provided their usual quarterly reports, so we were reviewing figures from the 9-30-16 Ameritrade statements. (Subsequent to the meeting, Howard contacted Oakeson and he immediately provided their 9-30-16 quarterly reports which were in good order and were distributed by email to all Foundation board members.)

After a review of the information, the board approved the profile of investments.

# 7) Session Report from Kay/New Business

Howard had received the 10-31-16 Fund statements and noted there were small losses in all funds for October. However, the first 2 ½ weeks of November had seen gains that more than made up for the October losses. After some discussion, the consensus was that our Board feels uncomfortable with "guaranteeing" an amount of distributions, but, with the markets increasing so far this year, our board would think distributions would be at least the size of the 2016 distributions and maybe 1% higher (4% vs 3%), if the markets hold onto the present gains during the next 2 months.

8)Trustees Report – Harrington

John was absent and there was nothing to be discussed related to the trustees.

9)Old Business –

Already discussed most of it.

10)New business-

The board thanked Roger Doerr for his leadership during 2016.

The next meeting was set for 2-13-17 at 5:30 PM in the Anderson room.

Doerr adjourned the meeting with a prayer.

Motion and a second to approve the recommended changes; upon a voice vote, motion carried. Motion and a second to completely strike Article IX – the Board of Personnel so it becomes a

committee of session. Upon a voice vote, motion carried.

Motion and a second to strike Article 3, Section 7 as it relates to electronic voting. Upon a voice vote, motion carried.

All recommendations will be brought back to Session for final review in November and presented to the Congregation at the Annual Meeting.

**Triennial Visit by Committee on Ministry:** Polly Deppen-Williams as moderator of Committee on Ministry conducted the Triennial Visit on behalf of Presbytery.

**Christian Education:** No action items to bring forward.

**Worship, Arts & Music:** Recommend that the bell choir, Rezound, be allowed to receive a free-will offering during their concert on June 18, 2017. Upon a voice vote, motion carried. Recommend that \$4150 from the Langenberg Fund be used to purchase a 5-octave set of bells. Upon a voice vote, motion carried.

Recommendation that Communion be celebrated as usual on January 1, 2017, the first Sunday of the month. Upon a voice vote, recommendation approved.
